PRESIDENT'S REMARKS

Our mini convention is actually a forum were by NEC Members meet to take

It was agreed that NEC should have quarterly conference calls.

FUND DRIVES

The house agreed that we continue with Boston 09 and D.C. 2010 RESOLUTIONS All fund drives have to go through chapter presidents and in situations where a chapter does not exist, NEC has to approve the drive. The rational is for us to be consistent and fair to all. In situations where a member is not a registered Soban, the fund drive will be conducted, with the fund coordinator indicating that the member is not registered. After the drive is completed, national and chapter dues will be deducted and sent to the national and chapter treasurers respectively, before the proceeds will be handed to the individual. If such MEMBERS do not continue their membership dues henceforth, they will not get any further ASSISTANCE from Soba America.

NEC will also put a disclaimer on fund drives that are not approved by SOBA AMERICA. Any request for help using the Soba America forum will be required to have the disclaimer; otherwise the moderator of SOBA AMERICA will stop the drive after having informed the fund coordinator to abide by our by-laws

SICK BAY

The house upheld the resolution of Boston 09. The \$10000.00 pledged by SOBA AMERICA towards the sick bay stands until the end of 2011 Soba fiscal year. The GA will decide if the funds could be used for different projects after the said period. Furthermore, Soba America will only release the funds when we know where the rest of the funds to complete the project will come from.

Christmas Eve 2010 Party: Traditionally Soba-Georgia hosts a Christmas party and this year's event is around the corner.
