Why our chapter is unique: We keep working diligently to find more joint investment ideas for SOBA Dallas member so as to foster our unity in events beyond Soban activities. We are considering starting a social club to carry out our investment ideas. We feed off each other and always try to share information to improve each member's life. Our chapter plans on reviewing more activities we can do monthly as a group out of meetings. We currently have family outings or barbecue every four months. We also have an annual end of year family party. In our last party, Sobans took turns during the gift part of the event to surprise their wives with gifts as they thanked them publicly while addressing the crowd.

Our genuine commitment to help SJC directly and indirectly is what makes our chapter unique. We don't plan on waiting for others, but would continue small projects each year to help make SJC a better place. We could not have been blessed with a better set of dedicated Sobans.

SOBA Dallas plans on working with nearby chapters as a team in sharing ideas and supporting each other. We recently sent delegates (Frederick and Mola Ndoko) to SOBA Houston to show support during their elections and encourage them on the progress they have made. We were delighted to be part of this special day for SOBA Houston. SOBA Dallas offered to sponsor their youngest Soban 100% free to next convention in Minnesota. An invitation our executive decided to honor. He is so young we would be glad to present him in Minnesota. It represents hope that we can attract even very young Sobans.

### What We Expect From NEC

Our expectations from NEC have not changed. As earlier stated: We hope our national executive can use our 501C statues and other available means to generate funds so local chapter don't have to keep raising money for national project. Not long ago we donated for the IT project during our mini convention in Dallas. Now it is the sickbay project. We must realize that constant request from local chapters is one of the reasons some members don't join our local associations. They find themselves raising money for funeral which they do with pride but get fed up of added burden from national projects and projects not initiated by SOBA America. Donations for parties, deaths, membership and other local activities are enough to scare some members. So, let us limit it to that and not add more national projects to local chapters. Local chapters would always willingly assist to get funds from other sources not necessarily local members. NEC should figure out a way of functioning with only annual contributions and convention funds. Any additional donations should not be mandatory or passed to

-chapters. Generous and successful Sobans should be encouraged to help out. Some members simply can't afford it and stay away due to the financial pressures we put on them. NEC should continue working on ways of generating funds from other groups, conventions and corporate or small business partners. During the mini Convention, President Ntopi made this one of the critical things we as an association must address.

We also hope to have updates on NEC current projects regularly. For example every three months so we can see the progress we are making and be kept informed on the updated timely. It would be good if we get such information to the general forum every quarter. If we do this, we would be able to evaluate what progress has been made since the last convention and see what areas are problematic and need attention. This would ensure that we get at least 4 reports on each project before each convention. We would be able to evaluate some projects like the Sick Bay, Father Nomi Complex and Scholarship Fund periodically.

NEC should also bring SOBA America accounts and legal status into compliance. We should make sure we are in compliance with the laws governing all parts and legal obligations of our association. This includes commitments to our local communities such as community service and involvement.

Proposals By SOBA Dallas At 2013 Mini-Convention

- 1- Improving the way SOBA America functions, its image and a new global rebranding effort to set new and higher standards.
- 2- Planning of major renovation gift (sports complex) as proposed by president Ntopi. We requested updates and asked the delegates for substantial funding if SOBA America really wants to complete this project with style. We requested to donation goal of about 20,000\$ towards this project. This would make the renovations significant and befitting of SOBA America's reputation of generous gifts to SJC. We proposed getting more funds by making a bronze plate which will be displayed with names of donors who give above a certain threshold at the facility or appropriate location at SJC (proposed same in 2013). That will help raise funds for complex renovation. In the absence of such funds for a major

facelift, we proposed smaller gifts like state of the art dry marker boards for class rooms in S.J.C Sasse. Such a project would be cheaper and impactful. Providing dry markers for the boards annually would be very affordable. Most of these expensive projects we turn to engage in end up in many cases as pipe dreams for many years. Let us focus on smaller projects we can achieve which would be in many cases more appreciated by students of S.J.C.

- 3- Arrange for SOBA America's president to visit Cameroon a couple of times at some point to attend a SOBA preparatory meeting, visit complex with architect, and make concrete plans on renovation of complex. We can't run a successful project from here by simply delegating responsibility.
- . 4- Proposed that Soba America suits be assigned to a SOBA America member. SOBA America has not had suits produced in a while.
- 5- Proposed that investment groups be encouraged amongst SOBANS during conventions. Minnesota has a similar group. SOBA America delegates should have a time slot for presentation of such ideas by fellow members and interested members can meet privately during conventions. We should consider creating such investment groups or social club a separate entity from our 501C structure.

### 5. SAGI by VP Dr Kevin Nana

SAGI is an insurance scheme that we want SOBA America to be part of it. The objective of SAGI is simple.

If you are a member who dies here in America, SAGI will pay for the repatriation of your remains to Cameroon. You can also register you family members.

Once register, you name was correspond to your passport ID and SAGI will give you a matriculation number which corresponds to that name.

We have 2 questions that we need to answer to determine if you can be a member of SAGI.

- 1. Do you want to be buried in Cameroon?
- 2. Do you belong to an Association that is based in USA that has more than 10 members?

If you answer to these questions is yes, then you can be a member of SAGI. If your answer is no to any of the questions above, you can not be a member of SAGI.

Membership dues: There are no membership dues to belong to SAGI. You become by affirming that you want to belong to SAGI through your answers to the questions above. Since there are no annual dues, there is a \$20 fund that each member send to their treasurer as a down payment towards your due to your particular association so that when there is a die, the treasurer will deduct your share from that \$20 until it drops down below \$5 whereby you are asked to replenish the fund.

If there is a death, an announcement is sent to the members of the SAGI. SAGI makes a contribution to that family of \$15000 and takes over the arrangement for repatriation of the body including contact with funeral homes and payment of flight etc. After the arrangements are finalized, the family will get the remainder of the what is left of the \$15000.

Every association has **one week** to contribute their share to SAGI. Currently, that is about is \$3 per member. The goal is to have each member contribute \$1 towards the repatriation of a member to Cameroon, there are not there yet. If the association that the member belongs to does not send their total contribution to SAGI within one week, the entire association with all its members is removed (cancelled) as a member of SAGI.

The amount of association which that association was supposed to pay, will then be redistributed to the entire SAGI organization to come up with that sum that was short.

#### **SOBA America Life Insurance by Quintus Enow**

We have been talking about life insurance for more than 20 years and last year, SOBA America gave us the go ahead and make this happen.

Sam Ndeley who is a representative for the Cultural group here in Minnesota was contacted. We were priced for 40 people for quote of less than \$120 per year. Members get \$25,000 for benefits when fully vested which is after one year of membership. For the first year you only get half of the \$25,000. Note: you will receive \$25000 until you are age 65. After age 65, the amount drops but as you get older, your premium also reduces.

Last year was our renewal. Renewal is every November 1st. There is no medical examination for the first year. For the second year, each new members is required to do a medical exam but luckily, we were not asked to do that for our new members. If you are interested please call Quintus so he can add you.

I think the answer is probably not because we are just prodding along. We want to make our association relevant to its members. and be a lot more successful


We want to create a strong link with US and SOBA in general so we can share ideas and figure out how we can move forward.

## Special Projects: Class of 1972 by Dr Kunju

He went and asked our workers to stop the project and 3 weeks ago, our class stopped the gate Project, we later found out that Bishop Bushu did not give them the permission for this.

The class of 72 have stopped this project and returned the monies contributed to its members. Our class will do something individually with students directly. The class will help with the Sponsorship of orphans to attend Sasse.

This is just to update the General Assembly.

A petition is being circulated here in the General Assembly to sanction the SOBA President General. The petitioners believe that he has acted unlawfully and unethical. There has to be the rule of law. We need to make the President General know that we are un happy with his decision to stop a project that has been blessed by our Bishop.

An needs opportunity needs to be given to President General to hear his version of his story. Members called on the General Assembly to draft a letter to SOBA President General to hear his version of the story.

If his response is negative and Dr Kunju's version is correct, then SOBA America needs to suspend all financial contribution to SOBA Cameroon.

SOBA America President cautioned that this is not a SOBA America problem and we should refer this matter to the Class of 72, Yaounde chapter and SOBA Cameroon.

#### Other Matters: General Assembly discussion including convention venue

Who will host our next convention. Take into consideration that next year is an election year. Two cities Montreal and Houston are biding to host our convention.

Montreal has been promised to host our next convention but considering that next year is an election year and some of us have "doki" problems we need to take this into consideration.

Montreal is a full member of this association and needs to be given the respect to host our convention whether it is an election year or not. There have not been a year where 100% of its members attend conventions. If there are 60% of members in attendance, then we carry out the election.
