



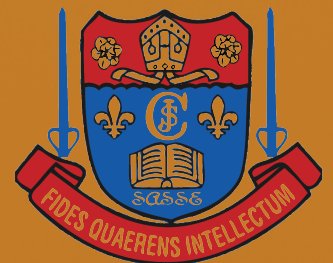

BYLAWS**1. Article II: 2.1 Annual Meeting**

CURRENT PROVISION:

A meeting of shareholders of the corporation shall be held annually. The annual meeting shall be held at such time and place on such date as the Directors shall determine from time to time and as shall be specified in the notice of the meeting.

PROPOSED AMENDMENT:

(i) A meeting of the shareholders of the corporation shall be held annually on the weekend preceding Memorial Day. The place of the meeting shall be determined by a majority vote of the General Assembly.

(ii) The Board of Directors working with the incumbent administration are empowered to change the location and time of the annual meeting only in the face of special circumstances where maintaining of the GA agreed time and location may put the lives of the shareholders in danger, or may not be logistically feasible. The absence of clear circumstances here does not limit the intent of this article or give liberty to the Board of Directors.

2. Article IIA – Shareholders: 2A.1 Shareholder Eligibility

CURRENT PROVISION:

- a. Shareholder status is open to all ex – students, former teachers and staff of Saint Joseph’s College, Sasse resident in the United States of America and Canada who meet criteria set forth in these by-laws.
- b. Ex – students, former teachers and staff from other than these two countries may become Class “B” shareholders without voting rights. The corporation may convert their shares to
- c. Class “A” shares if and when the class “B” stockholder decided to move to live in one of the two countries.
- d. An active shareholder shall be an ex-student, former teacher or staff who has paid his annual subscription fees for the purchase of his annual allotment of Soba America shares, attends meetings and contributes to SOBA America activities financially and otherwise.

PROPOSED AMENDMENT:

Shareholder status is open to all ex – students, former teachers and staff of Saint Joseph’s College, Sasse resident in the Americas, who meet criteria set forth in these by-laws.

3. Article IIA – Shareholders: 2A.3 Definition of a Shareholder. Section (b)

CURRENT PROVISION:

Shall be registered with the corporation by paying (1.) his registration fees, if any, and (2.) by requesting an allocation for and subscribing to 20,000 shares of common stock for which he would then pay annual subscription payments of One Hundred Dollars (\$100.00) per annum. Each annual subscription payment of \$100 shall entitle the subscriber to 100 shares, which shall become vested after the twentieth full year of consecutive subscription payments. A shareholder shall be eligible to accelerate his full vestment after the tenth year.

PROPOSED AMENDMENT:

(i) Annual shareholder dues are set at \$150 per fiscal year

(ii) \$100 shall be designated to the General Fund

(iii) \$50 shall be designated to the SOBAN Death Fund.

4. Article IIA – Shareholders: 2A.3 Definition of a Shareholder. Section (c)

CURRENT PROVISION:

Each shareholder shall have paid his annual shareholder subscription payment of \$100 on or before December 31st of each SOBA America fiscal year to qualify for full benefits of his shareholder status for that fiscal year, as defined and prescribed in these by-laws. Failure to comply with this deadline shall lead to forfeiture of shareholder benefits for the said fiscal year, until the shareholder becomes current, unless otherwise stated in these by-laws.

PROPOSED AMENDMENT:

(i) Shareholders have until August 31 to pay their dues and be in good standing to receive shareholder benefits.

(ii) Shareholders who pay their dues after August 31, are not eligible to receive benefits until after six months have passed from the date of payment.

(iii) New shareholders who register with SOBA America mid-year, shall be eligible for shareholder benefits only after a six-month period shall have passed from the date of registration.

(iv) Members must keep a paper trail of their payment of dues. Once you make payment, be sure to make a public announcement on their chapter forum.

5. Article IIB – Fiscal Year: New Proposal

(i) SOBA America fiscal year runs from June 1st to May 31st. Thus, shareholder dues shall run annually from June 1st to May 31.

(ii) All dues reset on June 1st. That is, if a member, new or current pays their dues in January, that dues is only valid till May 31st of that year.

(iii) viii. At least 6 months of registration is required for one to be eligible to vote at the SOBA America Convention.

6. Article IIA – Shareholders. 2A.4 Shareholder Benefits – Family Unity Recognitions

CURRENT PROVISION:

SOBA America Inc, if formally notified in writing, will recognize and reward registered members as follows:

- (i) 10 years of marriage - \$100 plus fund drive initiative;
- (ii) 25 years of marriage - \$250 plus fund drive initiative;
- (iii) 50 years of marriage - \$500 plus fund drive initiative;
- (iv) Newlyweds, if formally invited, - \$100 plus fund drive initiative.

PROPOSED AMENDMENT:

Members who formally invite SOBA America to their weddings shall receive a onetime check of \$250 from SOBA with no fund drive.

(i) Members who have been married for 10 years shall receive from SOBA a onetime check of \$500 with no fund drive.

(ii) Members who have been married for 25 years shall receive a onetime check of \$1000 with no fund drive.

(iii) Members who have been married for 50+ years shall receive a onetime check of \$2000 with no fund drive.

Appendix

i. For Members to get their benefit, they must inform the SOBA America President of their impending marriage or anniversary at least 2 weeks before the day.

ii. Legal marriages shall include, traditional marriages, religious marriages and Justice of the Peace contracted marriages.

7. Article IIA – Shareholders. 2A.6B – Shareholder Eligibility: New Provision

To qualify for benefits, a shareholder must be currently registered and up to date on all mandatory contributions.

The Board of Directors may grant a waiver to a shareholder not up to date on mandatory contributions if that member has a historically 95% participation record.

8. Article IIA – Shareholders. 2A.7 – Shareholder Conduct – New Provision

Any shareholder who brings public scandal to the SOBA name by his actions or words, shall be immediately suspended from all SOBA America affairs by a super majority vote of the SOBA America Board of Directors after a thorough review of the facts. He shall have recourse to appeal his suspension at the next General Assembly following his suspension.

(i) The Board of Directors shall immediately inform the membership through SOBA America’s chat platform/forum of its intention to take up the matter

(ii) The accused member shall appoint an advocate who shall advocate on his behalf before the Board of Directors.

(iii) The Board of Directors shall review the facts of the case and make a decision accordingly.

(iv) All minutes, communication and recordings of the hearing before the Board of Directors shall be published immediately.

(v) At the next General Assembly following said suspension, the General Assembly shall have a hearing of the matter and shall either reinstate the member, maintain the suspension for a definite period not to exceed 2years or expulsion.

9. Article III – Board of Directors. 3.1B – Jurisdiction – New Provision

(i) The Board of Directors shall have jurisdiction over all facets of SOBA America as prescribed by these bylaws of SOBA America

(ii) The Board shall approve all SOBA America budgets

(iii) The Board shall offer advise and consent to all policies and actions of the SOBA America Executive

(iv) The Board shall have original jurisdiction over all disciplinary matters concerning SOBANs and SOBA America

(v) The Board shall not infringe on the Executive functions of the National Executive.

(vi) Ultimately, the Board is subject to the General Assembly and may not make any decisions contrary to the expressed wishes of the General Assembly.

(vii) Records of Board meetings, votes and all written communications are properties of SOBA America and must be preserved on sobaamerica.org.

10. Article III. Board of Directors – 3.2 Composition

CURRENT PROVISION

The shareholders shall fix by resolution the precise number of members of the Board of Directors, provided that the Board of Directors shall consist of not fewer than one (1) nor more than thirty (30) members. Directors shall be elected at each annual meeting of the shareholders and shall serve for a term of two years and until their successors are elected. All resolutions adopted and all business transacted by the Board of Directors shall require the affirmative vote of a majority of the Directors present at the meeting.

There shall be two classes of Directors:

(a) Executive Directors shall be elected bi-annually at the annual meeting of the shareholders on odd numbered years, and shall serve for a term of two years or until their successors are elected

(b) Non-Executive Directors shall be chapter/branch presidents who shall automatically, by virtue of being elected as chapter/branch presidents, represent the chapter or branch on the Board of Directors. A branch president may nominate another member of his chapter to serve on the Board of Directors in his stead.

(c) Appointed Directors: The President of Soba America shall have the authority to appoint up to 3 (three) members to the Board of Directors. He shall have up to sixty (60) days from when he takes office to make his appointment and notify the other board members in writing.

(d) Past National President Directors: All former Presidents of Soba America shall have a permanent seat in the Board of Directors.

PROPOSED AMENDMENT

(1) Chapter Presidents shall serve as Directors on the Board

(ii) The President of SOBA America shall serve on the Board as an ex-officio member

(iii) The Vice President of SOBA America shall serve on the Board as an ex-officio member

(iv) The immediate past President of SOBA America shall serve on the Board

(v) The General Assembly shall elect three at-large Directors to sit on the Board. They must be eligible for elective office in accordance with provisions in these by-laws. They are subject to the provisions in Article IV A of these bylaws governing elections of Officers.

(vi) The last three Presidents of SOBA America including the immediate past president shall serve as Directors on the Board with voting rights.

(vii) The remaining past Presidents shall serve as non-voting Directors.

11. Article IV – Officer. 4.2 President – New Provision

(i) The President of SOBA America may appoint deputies for the Treasurer, Financial Secretary, Organizing Secretary and Publicity Secretary as needed.

(ii) The Board of Directors must approve by a simple majority vote such appointments. (iii) The President shall exercise other powers as prescribed by these bylaws.

12. Article IV-A – Election of Officers. 4.9 Eligibility – New Provision

(i) All candidates must have attended at least three of the last five National Conventions and among which they must have attended two consecutive National Conventions in the last three years leading up to the Convention in which they seek to be elected.

(ii) Any candidate seeking office must show to the Electoral Committee that he has no felony conviction. No convicted felon may hold any office in SOBA America be it National or Local.

(iii) All candidates seeking office must have demonstrated that they are men of the highest moral character.

(iv) No one may hold more than one office in SOBA America at the same time.

(iv) No one may hold an elected position in SOBA America and an elected position in a local chapter at the same time. A person who seeks a National Office, must be aware that

if elected, he must step down from his local elected position.

(v) All candidates shall submit their applications along with a \$100 filing fee to the Electoral Commission.

13. Article IV-A – Election of Officers. 4.10 Candidacy

CURRENT PROVISION

All Executive Officers are elected individually in their own right.

PROPOSED AMENDMENT

(i) President and VP elected as a ticket. The Presidential candidate shall have until two weeks before the deadline for declaration of candidacy as prescribed in these by-laws, to nominate Vice-presidential running mate. Same eligibility criteria as prescribed shall follow. If there is no VP running mate by the deadline, Presidential Candidate's candidacy is voided.

(ii) President nominates candidates for the other Executive Offices. The Board of Directors will vet the candidates and confirm or reject nomination by simple majority.

(iii) If Board confirms, officer shall be seated. If the Board rejects, President nominates a new person for that office

(iv) Current NLT members continue to serve in an acting role until new cabinet member is confirmed once the new president takes office.

(v) Cabinet members serve at the pleasure of the President and can be fired by President.

14. Article IV-A: Election of Officers – 4.20 Term of Office. New Provision

An Officer term shall be 2 years. No officer shall serve in the same position for more than two (2) consecutive terms.

15. Article IVA – Election of Officer – 4.21 Removal from office/Impeachment. New Provision

Any elected officer who is deemed to have grossly neglected his duties, abused his position conducted himself in a manner which is harmful to the organization, or conducted financial improprieties shall be impeached and removed from office by a two-thirds majority vote of the Board of Directors after due process, Officers may be removed from office for at least the following misconduct:

- a. Financial Improprieties
- b. Convicted of Domestic Violence
- c. Demagoguery of the SOBA Name
- d. Purposefully deceives the General Assembly or her representatives about any matter
- e. The enumeration in these bylaws of certain misconducts shall not be construed to preclude or disparage any other misconduct not here listed.

16. Article VII – Amendments

CURRENT PROVISION

These Bylaws may be amended by a majority vote of the Board of Directors of the Corporation or by majority vote of the shareholders, provided that the shareholders may provide by resolution that any Bylaw provision repealed, amended, adopted or altered by them may not be repealed, amended, adopted or altered by the Board of Directors.

PROPOSED AMENDMENT

(i) SOBA America Bylaws shall go through a complete top to bottom review and if necessary, a complete overhaul once every 10 years.

(ii) Amendments to the Bylaws can be suggested and accepted throughout the year, debated and voted upon at the annual General Assembly of SOBA America.

(iii) Only the General Assembly may amend these Bylaws after a majority vote at the annual General Assembly.

17. Article IX- Miscellaneous. 9.3 Use of SOBA America name, logo and Intellectual Rights – New Provision

The SOBA America LOGO and name are property of SOBA America. Any chapter, class or individual who wishes to use the LOGO and name must obtain written permission from the President of SOBA America or his representative, acting on behalf of SOBA America. Such permission shall be limited to the specific purpose for which it was sought and shall not apply for any other use.

Any intellectual property, invention, subscription or other obtained on behalf of SOBA America by and Officer of SOBA America or other Shareholder, acting on behalf of SOBA America, shall be property of SOBA America.

Any Shareholder who violates the provisions of this article by refusing to hand over such property to SOBA America or abusing the permission granted by SOBA America or commits any other violation of this provision shall be subject to disciplinary action as prescribed in these by laws or as determined by the Board of Directors in accordance with provisions of these by-laws.

Force Majeure Exception to Current Administration

Given the extraordinary circumstances brought upon us by an Act of Nature/Force Majeure with the devastating COVID-19 pandemic, the ability of the current administration to execute its vision for SOBA America has been severely hindered.
